One Wellness Teacher (counsellor) is required to be appointed. 4. The school is required to appoint more trained & qualified teachers to maintain section/teacher ratio 1:1.5 as per norms of the Board. 5. The school is required to ensure time to time renewal of all mandatory safety certificates.
