- That the society shall abide to the rules and regulations made in the Government order 1st to 3rd above.
- That the society shall provide the necessary amenities like accommodation, Sanitary facilities, Drinking Water facilities, Furniture, Library, Laboratory Equipment, Play Field required staff as per the staff pattern and other facilities are necessary, before approaching the competent authority.

3. That the society shall apply for recognition by 31st August at the latest duly

fulfilling the conditions.

 That the permission accorded is restricted to this year only and it is not valid for subsequent academic year.

That this permission does not confer any right on the society for claiming recognition.

- That the permission is accorded to Samsidh Educational Trust and no other society or body can open a school on their behalf of.
- The permission is accorded to open the school premises in the locality and there shall not be change in the premises or locality.
- The society shall provide the necessary material even if it costs more than the deposit amount.

- Proper and adequate sanitation facility shall be provided for students especially for girl students.
- 11. Proper and adequate safety measures shall be taken for children within the school campus and also near the school premises.
- 12. The school shall follow the traffic and safety guidelines indicated by the police and fire services departments.
- 13. The parent Teachers Associations meeting shall be conducted to sensitize the parents on the safety of the children.
- 14. The school shall have first aid kit and the teachers shall be trained in first aid.
- 15. The management should fulfill all the conditions as per G.O.Ms.No.41 Education, Dated.11.5.2006 at the time of applying for Provisional Recognition.
- 16. The management is hereby informed that, the permission is being given purely on a temporary basis and is subject to the report of State Level Inspection and Vigilance Committee fulfilling of all the prerequisite conditions under A.P. Educational Act, 1982 and it later found that the school has not fulfilled any prerequisites as stipulated, the permission now being given is liable to be withdrawn at once.
