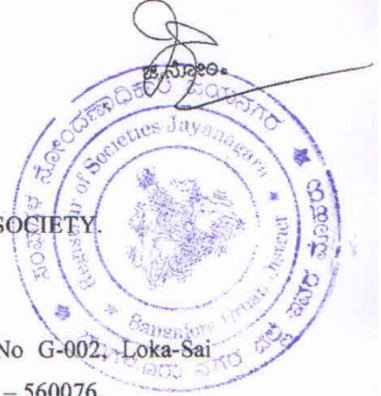

1. NAME

The name of the Association shall be SAMSIDH EDUCATIONAL SOCIETY.

2. REGISTERED OFFICE

The Registered Office of the Association shall be situated at No G-002, Loka-Sai Residency, 6th Main, 4th Cross, N.S.Palya, BTM 2nd Stage, Bangalore – 560076.

All communication meant for the SAMSIDH EDUCATIONAL SOCIETY shall be addressed to the above address.

3. AIMS AND OBJECTIVES OF THE ASSOCIATION :

1. The objectives of the Society are :

- To promote, establish and manage Institutions for Research, Technical Education, Health Care Education, Management Education, Colleges for Science, Commerce and Arts, and Schools for Nursery, Primary and High School Education in all its descriptions and kinds in India.
- To promote innovative teaching and learning methods in primary schools as well as in higher institutions.
- To promote and develop the employment skills for the unemployed youth, to develop entrepreneurship qualities to the graduates, under graduates, technically qualified persons and other people.
- To promote, establish, and manage Institutions for providing technical training, para medical training, educational instructors training in all its descriptions and kinds.
- To conduct or to contribute towards conducting seminars, workshops, short term courses, training courses, exhibitions in the field of education.
- To promote, establish and manage libraries, hostels for the benefit of the student community.
- To develop e-learning programmes for various classes and in all subjects of study.
- To publish or to contribute towards the publication of books, journals, magazines, research papers, in all subjects of study.

RULES AND REGULATIONS**



1. OBJECTS

The Association is established for the objects set out in the Memorandum of Association

2. INTERPRETATIONS

- The Act means the Karnataka Societies Registration Act 1960.
- The Rules and Regulations shall mean the Rules and regulations of the SAMSIDH EDUCATIONAL SOCIETY as herein contained or as amended, altered, or substituted from time to time.
- Association shall mean SAMSIDH EDUCATIONAL SOCIETY.
- Member shall mean a member of the Association whose name is entered in the membership register in accordance with the Rules and Regulations of the Association.
- Year shall mean the Financial Year of the Association which until otherwise fixed shall be from 1st April to 31st March.
- Words imparting the Masculine Gender shall include the Feminine Gender and words imparting the singular number shall include the plural number and vice versa.
- Memorandum shall mean the memorandum of Association of, SAMSIDH EDUCATIONAL SOCIETY.

3. MEMBERSHIP

- Membership in the Society is open to any person aged above 18 years and abides by the aims, objects and the rules of the Society.
- Any person may be admitted by the Executive Committee as a member on receipt of written application.
- The admission of any member shall be accepted by the Executive Committee by a resolution with at least 3/5th majority.

4. TYPE OF MEMBERSHIP

- a) Patron Member - A person who pays a minimum amount of Rs.20000/- towards membership is eligible for Patron Membership. A Patron Member is a member for his life time and the membership can be transferred to his legal heirs after his death as per his desire. If the member does not execute any WILL and if there is a dispute between the legal heirs for the purpose of membership of the society one person will be elected by the general body to retain the Patron Membership in the family of the deceased member.
- b) Life Member - A person who pays a minimum amount of Rs.10000/- towards membership is eligible for Life Membership. A Life Member is a member for his life time and the membership cannot be transferred to his legal heirs after his death.
- c) Ordinary Member - A person who pays a minimum amount of Rs.1000/- towards membership is eligible for Ordinary Membership. The Membership is valid for a period of one year.
- d) Professional Member - A person who has special abilities in promoting the objects of the Society may be nominated by the General Body for a specific period. He is called a specialist member.

5. REVOCATION OF MEMBERSHIP

- a) Any member may resign from his or her Membership in writing and his/her Membership shall cease from the date of its acceptance by the Executive Committee.
- b) The membership of any members shall cease from the date of his/her death.
- c) The membership of any member shall cease if he/she becomes of unsound mind or adjudged as insolvent or convicted by a Court law in a criminal offence involving moral turpitude.
- d) Any member may be disqualified or expelled from his/her activity antagonistic to the interest of the Society with at least 3/5th majority of those present at the General Body meeting convened for that purpose.

6. GENERAL BODY

The persons admitted as members as per the Rules 1 and 2 will be the members of the General Body.

7. EXECUTIVE COMMITTEE

The Management of the affairs of the Society is entrusted to the Executive Committee consisting of seven members. They are: President, Vice-President, Secretary, Treasurer and three Executive Members. The Executive Committee is empowered :

- a) To collect fees, subscriptions, contributions, donations from members.
- b) To authorize specific members of the committee to apply for and obtain donations, grant in aid, loans from Government of India, State Governments, Financial Institutions, Commercial Banks, and other public and private organizations, funding agencies for achieving the objectives of the Association.
- c) To raise funds for carrying on the objectives of the Association by borrowing or accepting deposits with or without interest, to acquire property, shares in any company, or partnership or concern and hold any negotiable instruments and deal with all or any of the m in any manner and create any kind of lien or charge as may be deemed desirable or necessary and generally to borrow money with or without security.
- d) To purchase, construct, take on lease or hire, assign, mortgage or otherwise, tenements, buildings, easement rights, and advantages of any kind whatsoever, occupy, maintain and use for the purpose of the Association.
- e) To enter into contracts on behalf of the Association.
- f) To insure against losses, damages, risk, and liabilities of any kind which may affect the Association wholly or partly.
- g) To pay all or any cost, charges, expenses whatsoever of preliminary, incidental nature or relating to the formalities of registration or establishment of the Association.
- h) To open and operate Accounts with scheduled banks.
- i) To make, accept, endorse, and execute Promissory notes, Bills of exchange and other negotiable instruments for the purpose of the Association.
- j) To invest the money of the Association, not immediately required upon such securities or in Bank Accounts as may be determined from time to time subject to the conditions laid down in section 11 of the Income Tax Act 1961.

- k) To appoint sub-committees to assist in its activities.
- l) To Co-opt members to the Executive Committee or to elect any office bearer in case any member of the Executive Committee or any office bearer of the Association duly elected by the General Body resigns, dies, or disqualifies himself to be a member of the Association.

8. FUNCTIONS OF THE OFFICE BEARERS

The office bearers elected shall be in office till new office bearers are elected and their functions, duties and responsibilities shall be as follows:

- a) President:
The President shall preside over the meetings of the General Body and Executive Committee.
He/she shall operate the bank jointly with the Secretary.
- b) Vice-President:
The Vice-President shall assist the President in his/her duties and in the absence of the president he shall preside over the meeting of the General Body and Executive Committee.
- c) Secretary:
 - I. He/She shall be the custodian of all the records of the Society.
 - II. The Secretary has the power to appoint employees of the Society and the same shall be ratified by the Executive committee within 4 months of such appointment.
 - III. The Secretary shall maintain minutes of all the meetings of the Society.
 - IV. The Secretary shall open and maintain the bank account in the name of the Society along with the President jointly.
 - V. He shall convene the meetings of either Bodies with the consent of the President.
 - VI. He/she shall carry out correspondence of the Society.
 - VII. He/she shall spend the amounts approved by the Executive Committee.
He/She can keep with him/her a cash amount up to Rs. 10,000/- and they advance expenditure shall be ratified by the Executive Committee.

VIII. He/she shall have the right to obtain any information that directly reaches the President.

IX. The powers excluding that of assigned to President, Vice President shall be vested with the Secretary.

d) Treasurer:

- I. The Treasurer shall maintain accounts of income and expenditure of the Society and submit accounts to the Executive Committee at its meetings.
- II. He/she shall deposit all collections in a scheduled bank or banks decided by the Executive Committee.
- III. He/she may keep with him/her an amount in cash not exceeding Rs. 1,000/- for day to day expenses of the Society.
- IV. He/she shall assist the Secretary in discharging his/her duties and in the absence of the Secretary he shall perform the duty of the Secretary.

f) Executive Committee Members

He shall help assist the executive body in discharging the functions in general for the betterment and development of the Society.

9. MEETINGS

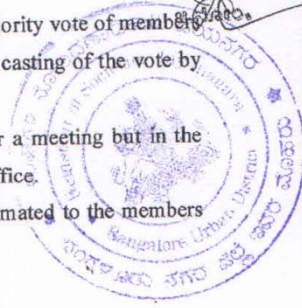
a) Executive Committee

- I. The Executive Committee shall normally meet at least once every month. More meetings of the committee may be summoned if necessary by the secretaries in consultation with the president.
- II. On receipt of a request in writing signed by at least one third of the members of the Executive Committee giving reasons for holding an extra ordinary meeting, the Secretary shall call an Executive Committee meeting.
- III. The quorum for meetings of the Executive Committee shall be four if there is no quorum, the meeting shall be adjourned and at the adjourned meeting the business of the original meeting shall be disposed off whether there is quorum or not.

- IV. Decisions of the committee shall be made by majority vote of members by show of hands and in the event of tie by the casting of the vote by the president.
- V. Ordinarily Seven days notice shall be given for a meeting but in the case of special meeting, 24 hours notice shall suffice.
- VI. The time and place of the meetings shall be intimated to the members in the notices calling for the meeting.



b) General Body Meeting

- I. The Annual General Body Meeting of the Association shall be held not later than six months from the close of the financial year.
- II. Twenty one days notice in writing shall be given to the members for the General Body Meeting specifying the place, time, date, and the business to be transacted at such meeting.
- III. The quorum for the General Body Meeting shall be one fourth of the total number of members. If there is no quorum the meeting shall be adjourned and at the adjourned meeting the business of the original meeting shall be disposed off whether there is quorum or not.
- IV. The decisions of the General Body Meeting shall be made by the majority of the members present and voting by show of hands or by any other procedure decided upon by the meeting.
- V. The Secretary shall present for the approval of the Annual General Body Meeting the Annual Report and Accounts of the Association.
- VI. A new Executive Committee for the ensuing year shall be elected at the meeting. Members of the outgoing committee shall be eligible for re-election.

10. SUIT

The Society shall sue and be sued in the name of the Secretary of the Society.

11. FUNDS

- a) Membership fees, funds, contributions, donations, grant in aid, and other collections shall form the general funds of the Association.
- b) The general funds of the Association shall be utilized for
- I. Promotion of the objects of the Association.

II. General Administration of the Association including Audit of Accounts

- c) Funds shall be deposited in a schedule bank or banks approved by the Executive Committee and the bank account operated on a joint signature by President and Secretary.

12. **AUDIT**

The Executive Committee shall appoint a duly qualified person to be the first Auditor and may remunerate him. Subsequent Auditors shall be appointed and their remuneration shall be fixed by the General Body. Accounts of the Association shall be audited once a year by the Auditors of the Association.

13. **AMENDMENT OF THE BYE-LAWS**

- a) Provided that no amendments to the memorandum of association, rules and regulations of the association shall be made which may prove to be repugnant to the provisions of Sec.2(15), 11, 12, 13 and 80G of the Income Tax Act 1961 as amended from time to time. Further any amendment carried out shall be forthwith reported to the commissioner of Income Tax.
- b) The funds of the association shall be invested in the modes specified under the provisions of Sec.13(1)(d) r.w.s.11(5) of the Income Tax Act 1961 as amended from time to time.
- c) Once the donation received by the Society will not be returned in any circumstances.

14. **GENERAL**

- a) At the meeting if both the President and the Vice President are absent, the members present will elect the President for presiding the meeting.
- b) Proper notice shall mean and imply that notice delivered in person or by post.
- c) A subject once disposed off in the General Body or in the Executive Committee shall not be reopened for one year.
- d) If any member of the General Body ceased or removed by the rules of the Society, he shall cease to act as member of the Executive Committee and Office Bearer immediately.
- e) The Financial year of the Society shall be April to March of the following year.

- i) No amendment to the Memorandum of Association and Rules and Regulations shall be made with may prove repugnant to the provisions of Section 2(15), 11 to 13 and 80G of the Income Tax Act, 1961 shall be carried out.
- j) The activities of the Society will be under the provisions of Foreign Contribution Regulation Act. Sec. 6(1) of 1976.

15. DISSOLUTION

- a) The Society shall be dissolved only by a resolution passed at a special meeting of the General Body called for the purpose by a majority of at least 3/5th of those present and voting when not less than two-thirds of the total membership of the society is present.
- b) In the event of the dissolution or winding up of the Society the assets remaining as on the date of dissolution shall under no circumstances be distributed among the Members of the Executive Committee / Members of Governing Body, but the same shall be transferred to another institution whose objectives are similar to those of this Society and which enjoys recognition under section 12A and 80G of the Income Tax Act 1961. Dissolution of the society shall be only after obtaining the acceptance of at least 3/5th majority of the General Body present.
